








Company development since 2006





Case study

Project: - Vindpark Døstrup Vest

(www.VindparkDoestrupVest.dk)

Key - Repower project

elements: - 2 Municipalities

Freeway location

- Mink farm and Horse stud farm within 800 meters

Project size: - 5 WTGs ~16 MW (5 WTGs to be taken down)



What have we done?

- We have focus on information in a early stage of the projects
 - → Facts before rumors, e.g. 16 MW are confused with 16 turbines...
- We prefer joint meetings instead of private ones
- In general we have (at least) 3 public meetings before a permit
 - → Area reservation, Pre-debat fase, and EIA public fase (together with "Los of value" meeting)





Main criterias for success

What are the main success criterias for good public participation and a successful project?

Visibility
Information
Political determination
Using the toolbox





Visibility

A wind project cannot and should not be taken ligthly.

- → Public meetings with political participation already in the pre-debate fase
- → Managing the press (when possible) Are the journalists positive, reflective or against the project?





Information

Accessible and factual information!

Public website from the Municipality dedicated to wind turbines www.Viborg.dk/vindmoller (the

link "died" with the projects)

- → Project website (developer)
- → Public meetings
- → Where to see similar turbines





Political determination

"Vi vil med en VVM undersøge muligheden for, om det er muligt at opstille vindmøller i dette område..."

"We want an EIA study and look at the possibility of whether it is possible to erect wind turbines in this area ..."

"Vi har bestemt, der skal være vindmøller i dette område, VVMen skal afgøre om der er lokale forhold, der kræver tilpasning..." "We have determined that there will be wind turbines in this area, the EIA study should determine if local conditions require adjustments ..."



The toolbox

- "Den Grønne Fond" (The Green Fund)
 - Funds should be appointed locally and be aware of this from the first public meeting
- Køberetsordningen

Three wishes?

- A term called "Windvorranggebite" like we have it in Germany. In short where a normal "Area reservation" equals an obligation to issue a permit after an EIA report
- The Municipality should be obliged to cover cost/loses when a projct is terminated without reasonable grounds
- More focus on the individual Municipality and their obligations


